	(1)	No person may own, establish, expand or maintain a junkyard, except the following:	
		(A) Within a zoned industrial area and otherwise in compliance with this ordinance.	
		(B) Which is not visible from the traveled portion of any city street or highway passing through the city limits of the City.	
	(2)	Determination of whether or not a junkyard is in compliance with this ordinance is the function and responsibility of the Zoning Administrator and the appropriate standing committee of the Council.

A non-conforming junkyard is one which:

Was lawfully established and maintained prior to adoption of this ordinance,

- (2) A junkyard retains its non-conforming status so long as it is not abandoned if inactive for more than one hundred eighty (180) days.
- Every non-conforming junkyard shall be screened, relocated, removed or disposed (3) of within eighteen (18) months after it becomes a non-conforming junkyard. Failure to do so will subject the owner to the penalty section of this ordinance.
- (4) Any legal process initiated under this ordinance or applicable Wisconsin Statutes must be preceded by a sufficient notice to apprise the owner of the junkyard that he is in violation of this ordinance.
- (5) Junked vehicles shall not constitute, by definition, a junkyard. Violations of the code relative to junked vehicles shall be determined by Chapter 18.

51.05 PENALTIES.

> Any person violating this ordinance shall be subject to a forfeiture of not less than \$50.00, nor more than \$250.00, for each offence. Failure to pay the forfeiture, upon conviction, will result in the issuance of a Civil Commitment
