Street closure for Holiday Parade on December 2, 2023. Jay Vehrenkamp spoke about having an ugly sweater 5K WALK/run. A waiver would be signed by all participants and the fee charged would go to a community need. Erika Anderson would like the day to be a Norwegian Christmas in Blair. There would be activities at the Community Center after the run with a lighted Community Christmas tree and live reindeer. Erika asked if the fee for using the Center could be waived for the event. Jeremy Tranberg volunteered to cover the fee for the event that day. She also asked that the City put up the lights on the tree and then dispose of the tree. Most businesses in Blair will be having some sort of activity or food for sale at their establishment. The event is also asking for a street closure. Mayor Rawson expressed that there was to be no alcohol thrown out at the parade. **Motion by A. Stevens to approve the street closure on Broadway, from Dover to Pearl, 2nd by P. Syverson. Payment Application #3 for Broadway/Pearl project – Charles Pearman, SEH. Charles stated that this work was from August 16 to October 16. Recommending payment of \$1,530,527.02. A-1 would like to have a cold weather waiver change order signed. Attorney Radcliffe stated that there should be no change order. This is on A-1 Contracting; not the City. Health insurance increased 16%. The fire department/community center share is now 49.9% for the City of Blair and 50.1% for the Town of Preston. Once again, we did raises first as our employees are our most valuable resource. The raises are based on performance and contingent upon certifications being passed. The average raise was 6.1% across the board. The Blair-Taylor Youth Association will receive \$5000, the police want a second squad car for \$42,000, lots of road projects (Tappen, Taft, city parking lot, sand blasting plow truck), 2-way radios for trucks, 2 new shelter refrigerators, and a shaded building for the pool. Capital Improvements include: \$9000 for police squad, \$15,000 for Fire Department, \$100,000 for Street Machinery, \$58,000 for Street Projects, and \$10,541 for Contingency. Motion by C. The Tax, Finance, & Personnel Committee has been asked by an employee to look into a Health Insurance Stipend for those employees who don't take the insurance from the City. They would like to be paid for not taking the City's insurance. The council verbally agreed to move forward and investigate a health insurance stipend.

Tri-City Sanitation garbage bin contract. Attorney Radcliffe stated an ordinance needed to be put in place for garbage collection and he has drafted one for you to look at. The Council needs to define the area that will be affected. Single family residence, duplexes, tri-plexes, and 4-plexes will be provided garbage bins. We will provide a map to Tri-City of where within the City they need to pick up. Motion by C. Ekern to approve Tri-City contract and garbage collection, contingent on residence re-definition, 2nd by J. Tranberg. Discussion: J. Anderson-when does this go into effect? January.
