Attorney Radcliffe went over the meeting held with the City of Blair and AMPI. Discussion revolved around excess grease going into the sewer system, and the potential need for a third well within the City of Blair. The City will be looking for a location to place a 3rd well as we are at maximum compacity with our water. Fines and/or citations for any business not following our ordinances was discussed. The City of Blair will also be scheduling monthly meetings with AMPI to keep the lines of communication open and ask and answer questions that arise.
