3.01 INCORPORATED CITY

The City of Blair is a duly incorporated city existing pursuant to its original charter and Chapter 62 of Wisconsin Statutes. Section 62.02 and 62.04 of the Wisconsin Statutes are hereby incorporated by reference. Further, the City is governed by this code, Chapter 62 through 66 of the Wisconsin Statutes, acts of the legislature and the Wisconsin constitution.

3.02 CITY BOUNDARIES

The boundaries of the City of Blair are set forth on the official City Map. The City Map, describing the corporate boundaries of the City is on file in the office of the City Clerk and is hereby incorporated by reference. A certified copy of the corporate boundaries of the City of Blair has been filed with the Secretary of State of the State of Wisconsin, pursuant to Section 62.02 of the Wisconsin Statutes.

3.03 WARD BOUNDARIES

The City shall be divided into three wards as follows:

- (1) FIRST WARD: The First Ward shall comprise all territory within the city limits of the City of Blair which lays East and North of a line described as follows:

Commencing at a point where South Tappen Coulee Road intersects the South Boundary of the city limits;

thence North on South Tappen Coulee Road to East Taft Street;

thence West on East Taft to Pershing Avenue;

thence North on Pershing Avenue to East Broadway Street;

thence West on East Broadway to North Gilbert Street;

thence North on North Gilbert to State Highway 95;

thence continuing North on North Gilbert, if extended, to Mill Road;

thence East on Mill Road to Granberg Road;

thence North on Granberg Road to the North Boundary of the City of Blair.

In addition, the First Ward shall comprise all territory described in Exhibit A and Exhibit B attached.

(2) SECOND WARD: The Second Ward shall comprise all territory within the city limits of the City of Blair lying West of the First Ward and the Third Ward, except the territory described on Exhibit A and Exhibit B in the First Ward.

(3) Third Ward: The Third Ward shall comprise all territory within the city limits of the City of Blair lying West and South of the line described as follows:

Commencing at a point where South Tappen Coulee Road intersects the South Boundary of the city limits;

- a. Thence North on South Tappen Coulee Road to East Taft Street;
- b. Thence West on East Taft to Pershing Avenue;
- c. Thence North on Pershing Avenue to East Broadway Street;
- d. Thence West on East Broadway to South Urberg Avenue;
- e. Thence South on South Urberg to West Fourth Street;
- f. Thence East on West Fourth Street to South Pearl Street;
- g. Thence South on South Pearl Street to the South Boundary of the City of Blair.
